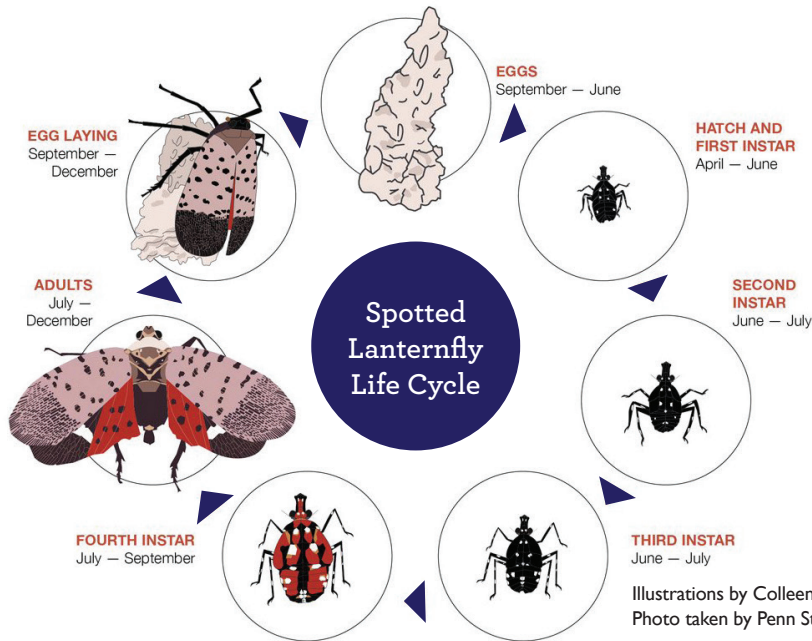




Contractors Guide to the Spotted Lanternfly

Spotted Lanternfly eggs and insects can be found on any surface including: cars, stones, wooden posts and buildings.

Permitting and Enforcements

The Pennsylvania Department of Agriculture has released an *Order of Quarantine and Treatment* effective May 28, 2018 stating all businesses within Bucks County are required to obtain a permit to move/transport/ and or work within or out of the quarantine.

How to Obtain a Permit: Visit the Penn State Extension website: <https://extension.psu.edu/spotted-lanternfly-permit-training>. This permit is not limited to individual vehicles it can cover an entire fleet. However, only one recipient is required to register for a permit.

Non-Compliance Penalties:

- Criminal citation up to \$300 per violation.
- Civil penalty up to \$20,000 per violation.

Road Side Inspections: Occurring at weigh stations, authorities will check for permits and noncompliance. Violators will be subject to fines under PDA's Order of Quarantine and Treatment.

Construction Site Hotspots

Staging Areas: Park vehicles and stage equipment 15 feet away from affected trees. All windows must be closed to ensure no SLF entry.

Loading Docks: Permits are required for moving equipment and goods within and outside a particular work site.

Onsite Clearing and Grubbing Areas:

- Remove any Tree-of-Heaven (*Ailanthus altissima*)
- Spray roots/areas around the host tree with herbicide. Typical spray volume is generally 50 gallons/acre.
- Chip the removed tree trunks in 1"x 1" pieces
- Burn the chipped material to kill future saplings
- **ANY/ALL TREE MATERIAL MAY NOT BE SOLD OR TRANSPORTED WITHOUT PDA APPROVAL.**

Onsite Management

On Site Material Inspections: Items found on the construction site i.e. shipping containers, pallets, E&S controls, building materials, silt socks, etc., **MUST** be examined before transportation or removal from site.

Vehicle Inspections: To mitigate the transportation of the SLF, it is imperative before leaving a worksite to check for eggs and insects. Doors, wheel wells, grills, bumpers, sides, and roofs are all common locations. If eggs are found, destroy immediately.
